



SPECIAL TERMS AND CONDITIONS OF THE ASSOCIATION SUEDOISE DE LA COTE D'AZUR INSURANCE AND ASSISTANCE POLICY No. 0803956

These Special Terms and Conditions are for your "Association Suédoise de la Côte d'Azur" Assistance and Insurance Policy, a personal insurance policy taken out with **Inter Partner Assistance** (hereinafter "**AXA Assistance**" or the "**Insurer**"), a *société anonyme* (public limited company) incorporated under Belgian law with share capital of €61,702,613 registered on the Brussels Trade Register under number 415 591 055, with its registered office at 166 Avenue Louise, Bte 1, 1050 Brussels, Belgium, **represented by its French branch** registered under number 316 139 500 with the Nanterre Trade and Companies Register, based at 6, Rue André Gide, 92320 Châtillon, France.

This Policy is distributed to the members of the Association Suédoise de la Côte d'Azur by **Assurances Services Courtage**, a *société à responsabilité limitée* (limited liability company) registered with the Antibes Trade and Companies Register under number 419 554 084 and registered on the register of insurance intermediaries (www.orias.fr) as an insurance broker, and with its registered office at 1630 Chemin des Combes, 06600 Antibes, France.

Assurances Services Courtage is appointed by the Insurer to manage Policies taken out.

PREMIUM

The amount of the annual insurance premium for your policy is:

INTENTIONAL OR UNINTENTIONAL MISREPRESENTATION

Any error or omission concerning risk components known to the Insured Person exposes him/her to the penalties provided by the French Insurance Code, namely: reduction of compensation or nullity of the Policy, with AXA Assistance retaining any premiums already paid (articles L113-8 and L113-9 of the French Insurance Code).

Any non-disclosure or misrepresentation relating to claim components (date, nature, cause, circumstance or consequences of the claim) known to the Insured Person exposes him/her in the event of bad faith to forfeiture of the cover under the Policy.

RIGHT TO CANCEL IN THE EVENT OF DISTANCE SELLING

The Insured Person does not have the right to cancel provided for in article L112-2-1 of the French Insurance Code, which does not apply to travel or baggage insurance policies or similar short-term insurance policies with a term of less than one month.

RIGHT TO CANCEL IN THE EVENT OF MULTIPLE INSURANCE POLICIES

In accordance with article L112-10 of the French Insurance Code, you are asked to check that you are not already covered for one of the risks covered by the group insurance policy that you have taken out. If such is the case, you can cancel your policy within fourteen (14) calendar days from when it was taken out, with no costs or penalties, if all the following conditions are met:

- You took out your policy for non-business reasons;
- You took it out to supplement the purchase of a trip by the Policyholder;
- You can prove that you are already covered for one of the risks covered by the policy you have taken out;
- The Policy that you want to cancel has not been fully executed;
- You have not submitted any claims under the policy you have taken out.

In this case, you may exercise your right to cancel your policy by sending a letter or any other durable medium to Assurance Services Courtage, at the address in the box above, attaching a document substantiating the fact that you are already covered for one of the risks covered by the new group insurance policy.

AXA Assistance is obliged to reimburse the premium paid within thirty (30) days of your cancellation. If you want to cancel your policy, but do not fulfil all the conditions above, check the cancellation conditions set out in your policy.
